### **NPCRC** Areas of Focus



- Exploring the relationship of pain and other distressing symptoms on quality and quantity of life, independence, function, and disability and developing interventions directed at their treatment in patients with advanced and chronic illnesses of all types;
- Studying methods of improving communication between adults living with serious illness with their families and their health care providers;
- Evaluating models and systems of care for patients living with advanced illness and their families.

### NPCRC Goals For 2020



- NIH funding for palliative care research will quadruple and all major Institutes will fund palliative care research.
  - Ensures adequate funding stream.
- All relevant NIH study sections will have ≥ 2 palliative care researchers.
  - Ensures appropriate peer review.
- The top 30 ranked medical/nursing schools in NIH funding will have ≥ 3 NIH R01 funded palliative care investigators.
  - Ensures adequate numbers of investigators and an adequate infrastructure to support new knowledge development and the development of the next generation of investigators.

### 2009 Baseline: Grants



- 114 active NIH grants in palliative care
- \$30,031,914 in FY 09 (.098% of total NIH budget)
  - NCI: \$13,179,833 (0.27% of NCI budget)
  - NINR: \$10,679,930 (7.5% of NINR budget)
  - NIA: \$5,534,584 (0.8% of NIA budget)
